The Annual Meeting of the members of KEM Electric Cooperative, Inc., will be held at the Linton Civic Center, 120 Cedar Avenue East, Linton, North Dakota, at 5 p.m. CT on Tuesday, June 10, 2025, to take action on the following matters:

1. Election of two directors

- 3. Proposed Amendments to Bylaws of KEM Electric Cooperative, Inc. The Board of Directors of KEM Electric Cooperative, Inc. are proposing one amendment to cooperative bylaws.

Proposed Bylaw Amendment Number 1:

NOTICE OF PROPOSED AMENDMENT TO BYLAWS OF KEM ELECTRIC COOPERATIVE, INC.:

The Board of Directors of KEM Electric Cooperative, Inc., is proposing an amendment to cooperative bylaws. This amendment will allow the cooperative's members to more efficiently fill vacancies which occur on the board of directors.

Bylaw 408 currently provides that the cooperative's members fill a vacancy by election at a member meeting. This will not change.

Bylaw 404 currently provides that candidates running for a director position must be nominated through a petition process that takes at least 150 days to complete. The proposed amendment will shorten the time it takes to complete the petition process. The amendment will apply to all director elections; those that occur through the regular expiration of terms and those that occur by vacancy.

Currently, nominating petitions are to be filed at KEM Electric's offices not less than 90 days prior to the date of the member meeting. Petitions cannot be signed more than 60 days prior to that date.

KEM ELECTRIC COOPERATIVE

The proposed amendment provides that (1) petitions must be filed on or before a date set by the board of directors; (2) petitions are not to be signed more than 30 days prior to that date; and (3) a list of candidates must be posted at cooperative offices at least 10 days before the election.

Passing this amendment will reduce the time required to complete the petition process and fill vacancies by member election.

The text of Bylaw 404 and the proposed amendment are as follows:

404 Member Petition-Form

- a. Each petition shall contain the following:
 - i. The name of the member nominee.
 - ii. The director position for which the member nominee shall run.
 - iii. The printed names, addresses, and telephone numbers, date of signature, and original signatures of each member signing the petition.
 - iv. At least 10 signatures of the members of the respective district, or members atlarge, as the case may be.
- b. In the case of joint members, the signature of one or more than one joint member shall constitute one joint signature.
- c. Firms, associations, corporations or body politics shall have the right to place one signature on a petition, the same as other members, by the signature of a duly appointed representative.
- d. Petitions may not be circulated or signed more than <u>6030</u> days before the date when petitions must be filed pursuant to this Bylaw. Any signature to a nominating petition obtained more than <u>6030</u> days before that date may not be counted.
- e. All petitions must be filed at the principal offices of the Cooperative not less than 90 days prior to the date of the meeting of the members as, <u>on or before the filing date</u> fixed by the board of directors.
- f. After verifying that a petition complies with this Bylaw, the secretary of the board of directors shall post a list of nominations for directors at the principal office of the Cooperative at least 6010 days before the meeting of the members.

This notice is given pursuant to Bylaw 1401 of the Bylaws of KEM Electric Cooperative, Inc.



CHAIRMAN'S REPORT

As Spring has sprung and the birds sing, the weather is fantastic for crops to grow, we find ourselves at anticipating another exciting year at KEM Electric Cooperative.

The team at KEM Electric have been busy upgrading parts of our system to help meet the demand and reliability that we as cooperative members have become accustomed to having.

I recently joked with the linemen one day, comparing their work to that of farmers setting up an electric fence. We ensure the fence is secure, so electricity continues to flow, keeping the cows where they belong. If the fence fails, the cows won't notice—they'll wander off and eat whatever they can find, often creating chaos before we realize it's broken. It's only when I hear cows mooing outside my window or get a call from a neighbor about his corn that I realize something went wrong.

Then it's all hands-on deck—well, all hands on deck for me—to track down the issue, reconnect the fence, and restore order.

When KEM Electric's "big electric fence" fails, however, the impact is immediately felt. The first call is to neighbors to check if the problem is widespread, then it's straight to the KEM Electric office. The team at KEM Electric is great at locating the outage area and sending a crew to look for and fix the problem. They are constantly testing, modifying and improving the system to keep the lights on. With the new modern switching methods, new styles of wire, new poles and underground wires we are striving to keep the electricity flowing through the lines more reliably.

While getting electricity back on is a top priority for our cooperative, I often feel that finding and fixing the electric fence at home still feels like a harder task. Perhaps that's because there's no new technology to streamline that process!

The KEM Electric Board of Directors and employees alike strive to ensure all members have safe, reliable and quality electric service.

In addition to the service we provide, we are also proud of the ways we support our local communities. This year, we're excited to continue our tradition of supporting local students by offering scholarships to high school seniors, sponsoring a student of the month program and hosting membership appreciation events. New this year, we are organizing a career tour to expose high school students to the wide array of energy-related jobs available within our state.

And of course, we are proud to be part of the KEM Electric membership. Each year we celebrate with our annual meeting. On behalf of the Board of Directors, I would like to invite you to our Annual Meeting on June 10 in Linton at the Linton Civic Center beginning with a social and registration at 4 p.m. with a business meeting to be held at 5 p.m., followed by a membership meal. We hope you can all join us for this annual event.

As your Co-General Managers/CEOs we continually focus on two key priorities: reliability and affordability for our members.

Over the past year, we've faced significant external pressures that have prompted a thorough review of our rate structure. Several factors are driving the necessary rate increases, particularly rising wholesale electric costs from KEM Electric's power suppliers, Basin Electric Power Cooperative and Western Area Power Administration. These increases are tied to investments in new generation and transmission facilities, essential for supporting member load growth, as well as crucial upgrades to their existing infrastructure to maintain reliability.

Our wholesale providers must adhere to the regulations set forth by regional transmission organizations, which are nonprofit entities mandated by the Federal Energy Regulatory Commission to ensure a stable power supply, adequate transmission infrastructure and competitive wholesale electricity prices.

Additionally, compliance with various regulations impacts our costs significantly. The power markets have become increasingly volatile, influenced by factors such as fluctuating natural gas prices and rising electricity demand. While our power suppliers manage this volatility through strategic generation and hedging, these measures have become more expensive.

At KEM Electric, we have also seen increases in material costs, maintenance, borrowing rates and insurance premiums. All these investments and cost increases are vital for enhancing the reliability for our members. Many of these maintenance expenses

are integrated into our base rate, which is essential for the upkeep of our system and sustained operational performance. By investing in our infrastructure now, we are positioning ourselves for long-term success.

This past year we have improved reliability through various projects which has lead to a notable reduction in our outage numbers. We have tested more than 4,600 poles, with around 70 being replaced. A new underground circuit was installed from the Linton Substation, reducing the south circuit by 22 miles of overhead line and 45 services, which should improve voltage, capacity and reduce outages. This upgrade also allowed for the retirement of two miles of old three-phase overhead line.

Regulators have been installed and moved throughout the system to improve voltage and capacity across various lines. We rebuilt four miles over overhead lines south of the Tappen Substation, damaged by last winter's ice storm. Additionally, over 30 trip savers were installed throughout the Krassna Substation area, replacing outdated oil circuit reclosures and reducing maintenance costs.

At the end of the day, we are working strategically to enhance our service to our membership, all while maintaining the affordability and reliability of our system. We want to thank each of our members for their continued support.



2024 ANNUAL REPORT

KEM ELECTRIC COOPERATIVE ANNUAL MEETING OF KEM ELECTRIC COOPERATIVE, INC. JUNE 11, 2024

The 80th Annual Meeting of KEM Electric Cooperative, Inc. was held at Our Club, Linton, North Dakota, on June 11, 2024. The meeting was called to order at 6:02 p.m. CT with Chairman Victor J. Wald presiding. The meeting commenced following an evening meal.

Chairman Wald gave the welcome address.

American Legion Post #54 of Linton presented the colors. Alexis Vetter and Emma Sanders played the national anthem. John R. Beck provided the invocation.

Chairman Wald introduced and appointed Cooperative Attorney Tom Bair as the Parliamentarian for the meeting. Cooperative Recording Secretary Connie Hill was also introduced.

Chairman Wald reviewed the contents of the packets that members received during registration.

Secretary Carter Vander Wal reported the cooperative's membership as of April 22, 2024, consisted of 2,234 members and with 120 members present at the time the meeting was called to order. The number of members voting in person was 53, members voted by mail were 255, members voted by web were 62. There were 37 spoiled ballots and 10 duplicate ballots by mail and online voting. The total number of member votes was 323. This number represented a quorum. Chairman Wald declared the meeting officially opened at 6:08 p.m.

Chairman Wald introduced the Directors. From District 1, John R. Beck; from District 2, Carter Vander Wal; from District 3, Neil Meidinger; from District 4, Victor J. Wald; from District 5, Dean Dewald; and from District at Large, Carmen Essig. The second at District at Large position is vacant and will be filled at this Annual Meeting.

Chairman Wald introduced the Co-General Managers/CEOs, Travis Kupper and Jason Bentz, and the individuals who served as election tellers.

Secretary Vander Wal validated the mailing of the 2023 Annual Report and the 2024 Annual Meeting Notice. Chairman Wald asked for a motion to waive the reading of the minutes of the 2023 Annual Meeting as it was printed in the Annual Report. A motion was made, seconded and carried.

Chairman Wald announced the next order of business was to conduct the voting on the 2023 Annual Meeting minutes and the election of three directors. Chairman Wald stated the director seats up for election and the nominees were John R. Beck from District 1 having been nominated by petition, Carter Vander Wal from District 2 having been nominated by petition, and Michael (Mike) Knoll and Anton (Tony) J. Schaffner from District at Large having been nominated by petition at this Annual Meeting. Mr. Beck and Mr. Vander Wal each addressed the membership.

Chairman Wald asked the membership to vote on all items brought forth as printed on the 2024 ballot. While the ballots were collected and counted, Co-General Managers/CEOs Travis Kupper and Jason Bentz were introduced.

Mr. Kupper gave a report on the 2023 KEM Electric activities. A video report on the 2023 audited financials was provided by Chief Financial Officer, Mr. Alex Craigmile.

A video report on operations was provided by Chief of Staff and Line Superintendent, Mr. Dale Nagel. Mr. Bentz continued to report on KEM Electric's business. A video report on member services was provided by the Manager of Member Relations, Ms. Marcy Sanders.

Mr. Nagel introduced guests in attendance.

Chairman Wald introduced Susan Meidinger, Vice-Chair of KEM Electric Operation Round Up. Ms. Meidinger reported on activities and introduced the Operation Round Up board members.

Ms. Sanders provided a video report on the scholarship winners, Ms. Sanders announced Teagen Erbele of Napoleon High School as the recipient of the Basin Electric Power Cooperative \$1,000 scholarship. The service area scholarships were also announced. Daniel Schumacher, Ashley High School; Grace Nicholson, Kidder County School: Emma Weiser, Hazelton-Moffit-Braddock Public School; Jazlyn Weigel, Napoleon High School: Rebekah Pool, Strasburg High School; Riley Richter, Linton High School; Dominic Meier, Zeeland High School: Abby Rivinius, Gackle Streeter Public School; were all recipients of the \$500 service area scholarships. There were no applicants from Wishek High School.

Ms. Sanders provided three Luck-of-the-Draw Scholarships. The scholarships were awarded to Morgan Huizenga from Strasburg, Cheyanne Lindgren from Ashley, and Gracyn Holzer from Linton. Each graduate received a \$500 scholarship.

Ms. Sanders announced the 2024 Youth Tour winner as Bridger Rivinius of Streeter. Ms. Sanders also announced the Student of the Month winners: Thomas Hass, Ashley; Emma Weiser, Hazelton-Moffit-Braddock; Alea Kramlich, Kidder County; Bailey Huber, Linton; Dawson Erbele, Napoleon; Malachi Huber, Strasburg; Travis Glaesman, Wishek; and Joseph Keller, Zeeland.

A brief question and answer period was held.

Prizes were awarded.

The winner of the \$600 progressive prize was drawn; however, they were not present. At the 2025 Annual Meeting, the progressive drawing will be \$700.

Chairman Wald announced the election results. The 2023 Annual Meeting Minutes were approved with 298 votes yes and 6 votes no, the winner for director in District 1 was John R. Beck with 294 votes, the winner for director in District 2 was Carter Vander Wal with 289 votes, and the winner for director in District-at-Large was Anton (Tony) J. Schaffer with 215 votes.

A motion was made, seconded and carried to adjourn the meeting at 6:57 p.m.
